GUIDELINES ON FIGHT AGAINST MONEY LAUNDERING PROMULGATED BY INTERNATIONAL ORGANIZATIONS

- The Forty Recommendations of the Financial Action Task Force on Money Laundering (FATF-GAFI) (www1.oecd.org/fatf/40Recs_en.htm). They constitute the basic framework of the fight against money laundering and they have being conceived for a universal application. They embrace judicial, penal and police system, financial system and its regulation, and international cooperation.
 GAFI acknowledged since the beginning that the countries have different juridical and financial systems, so everybody cannot the same measures. Therefore, recommendations constitutes the action principles on money laundering that the countries have to apply, in accordance with its particular circumstances and its constitutional framework, leaving the countries certain flexibility in its application instead of forcing to carry out with all the details: The measures are not specially complicated or difficult, whenever exists political actions will. Either jeopardize liberty to carry out legal operations neither threaten the economic development.

These Recommendations contain a set of measures aimed at combating the funding of terrorist acts and terrorist organizations, and are complementary to the Forty Recommendations. The FATF Forty and Eight Special Recommendations have been recognized by the International Monetary Fund and the World Bank as the international standards for combating money laundering and the financing of terrorism.

The finally of this is to reach or maintain a contract or other irregular benefit in the international economic activities development.
